### Notes for Entrants:

For practical reasons, assessment of entries will be carried out on the basis of information supplied on the entry form. Short listed contender projects will be presented to the panel and visited by the panel to verify suitability for the Award. Project chances are restricted when entries are not supported by sufficient material. Entries will not be returned.

*"The project qualities are not judged on the architecture or the interior design but are based wholly on the quality of the painting"*

### Assessment Procedure:

All forms must be completed by entrants, plus further documentation if required and the site visited by the panel.

### Judging Panel:

Generally should consist of 2 persons including a chairman with a casting vote.

One Judge may assist in more than one category.

Judges should have the purpose of illustrating and defining the standards used for judging to the members of the public.

*"These awards provide an opportunity for you to show the quality of your work to the industry, and also to use as a marketing tool to promote your business as a nominee/winner of your 'Industries Top Award' to your potential customers."*

### Conditions of Entry:

Each submission shall be accompanied by three 290 x 210mm photographs of the project suitable for display purposes.

The prescribed nomination form completed & signed.

The nomination fee paid.

Evidence of the practical completion of the work must be shown.

The nominator shall obtain the clients written permission for any publicity of which may result from the Awards program.

All nominees must be members of the Master Painters and Decorators Association.

### Clarification of Categories:

Heritage Restoration: Restoring a Building or Residence to its original heritage condition and need not necessarily include decorative finishes.

All Categories: All or part of a project may be submitted under one or more categories. Industrial projects will come under the Commercial category unless a valid reason can be given to create a separate category, i.e. Special finishes. Judges may recommend a special category be created if there are projects submitted which relate more specifically to another area. Judges may make a recommendation that your entry change category, with your approval, if it is deemed to be more suited to another group.
